



## Supporting the Community

In an effort to continue and strengthen our commitment to diversity, Foster Swift has also involved itself with the following initiatives:

- Support of the Davis-Dunnings Bar Association (formerly Lansing Black Lawyers' Association)
- Underwriting the Lansing Black Lawyers' Association Annual Otis M. Smith Scholarship since its inception.
- Corporate involvement in Lansing's newest women's professional organization, Athena WIN.

Foster Swift attorneys and staff are very active in the community. In April 2022, Foster Swift became a recipient of the 2022 Highfields Partnership Award. This award is given annually to an organization that helps Highfields fulfill its mission to strengthen the lives of children and families in their local communities.

What began in 1962 as a residential camp for troubled boys in Ingham County, Highfields Inc since then has taken their organization to new levels. They are now a multi-purpose human services organization which gives about 5,000 people every year the resources they need to turn their lives around. Foster Swift has been connected with Highfields since the beginning when the late Thomas G. McGurrin Jr. sat on the Board of Directors in 1962. Since then, members of the firm have continued to serve, providing countless hours of time and expertise in order to help Highfields be successful.

- Gazelle Girl Half Marathon, 10k and 5k – Foster Swift has sponsored this event since its inception. The event began in 2013 in celebration of the 40th anniversary of Title IX. The Gazelle Girl races connect women through movement, achievement, celebration, friendship and fun. Funds raised go to Kent County Girls on the Run, YWCA, G.R.O.W. (Grand Rapids Opportunities for Women), D.A. Blodgett St. John's Home, and Sisters in Support.
- My Team Triumph – myTEAM TRIUMPH is a 501(c)(3) non-profit athletic ride-along program created for children, teens, adults and veterans with disabilities who would normally not be able to experience endurance events such as triathlons or road races. myTEAM TRIUMPH brings the community together with the equipment necessary to allow them to experience the energy of packet pick-up and the thrill of crossing the finish line. They have active teams in other events the firm sponsors, including the Grand Rapids Marathon, Gazelle Girls and Tri del Sol.
- Tri Del Sol Triathlon – This was a new event in 2017. Tri del Sol is owned by myTEAM TRIUMPH.
- Love the City Week – Foster Swift's contribution helped recognize teachers of at-risk kids.
- James B. Hunter Golf Classic – Contributions went toward scholarships and a funding grant to Gaining Ground Educational Services, a free tutoring program. Ray Littleton was named to the Board of Directors in 2017.
- Volunteers of America – serve veterans, at-risk individuals and families. Several Foster Swift attorneys have attended their two big programs: Homeless No More and Veterans Tribute. Charley Janssen and Dave Russell serve on the Board of Trustees.
- Big Brothers/Big Sisters – Foster Swift has a long history of involvement on this board. Patricia Scott currently sits on the board. Foster Swift was the title sponsor of "Big Nite," their premier fundraiser. Over 50 percent of the children in the program are from an ethnically diverse family.

- Lansing Promise Scholarship – Foster Swift is a founding member. The Promise is an award offered to graduates of public and private schools within the Lansing School District (LSD) boundaries. It provides the financial assistance to obtain a two-year degree or its equivalent at an eligible school.

### **Volunteers**
